


Community of Practice



What is a Community of Practice?

- A Community of Practice (**CoP**) is a group of people who **share an interest or passion**, in common and come together to learn more about it. As the name suggests, communities of practice collaborate and communicate, sharing knowledge between one another as a community.
- Communities of Practice often focus on sharing best practices and creating new knowledge, to advance a domain of professional practice.
- In BioGov.net Communities of Practice are understood as regional co-creation labs bringing together the different stakeholder groups in a multi-stakeholder approach

What is their mission in BioGov.net?


- The CoP will contribute to create practical **knowledge and tools in order to bridge the gaps** between practitioners and researchers in the bioeconomy
- They will define regional needs and expectations on present and future educational programs
- Share knowledge on local bioeconomy successful Case studies
- They will co create educational guidelines for involving bioeconomy
- Identify need for skills required for present and future jobs in Bioeconomy
- Co-design innovative business models and methodologies for integration of humanities/art/design/culture and social innovation



How to create a CoP? 1. Identification of members

Stakeholders for CoP are initially identified through the local professional networks and organisations

Meaningful information is gathered for each identified actor (including type of stakeholder, knowledge on key elements, function, expertise, etc.).

Identified stakeholders are assessed based on selection criteria

Assess

Gather

Assessments are aggregated and a final list of stakeholders to be invited in each CoP is produced

Select

engage

Prospective members of CoP are invited and those who accept the invitation provide a signed Invite & Declaration of Acceptance



Selection Criteria



	Selection criterion	The rationale for criterion inclusion
	Interest	Individuals with high interest in the bioeconomy sector will ensure that they are driven to participate and help produce meaningful results with significant value-added for their users.
	Availability	Individuals that have the available time required to participate will allow to smoothly organise and execute activities with higher participation rates that will result in a higher probability that their targets are achieved.
	Relevance	The stakeholders' relevance to the scope and objectives of the CoP is necessary to keep the activities focused and will ensure that their members can effectively contribute to the production of relevant project outputs.
	Appropriateness	The members are appropriate to their scope thus avoiding conflicts of interest or involvement in activities that may cause them unnecessary inconvenience.
	Representativeness	A balanced representation of perspectives within and across stakeholder groups is key for the CoP to collect the representative insights required to inform design, development, and fine-tuning, thus addressing diverse needs.
	Willingness	Motivated individuals willing to contribute with their knowledge and experience will promote success of CoP activities and will be more prone to help disseminate the CoP's tools and knowledge
	Gender	Reflect the interests and needs of all genders
	Age	Potential stakeholders should not be overlooked on the basis of age. The knowledge and tools produced will be more relevant and therefore will have more practical value if age disparities of prospective users are taken into account.

How to create a CoP? 2. Invitation and engagement



- > An official invitation letter from the Cop Leader
- Terms of Reference providing meaningful information the activities in which members of CoP are included, as well as their expected contribution and conditions pertaining to their membership.
- Declaration of Acceptance to be signed by the invited stakeholders evidencing the fact that they agree with the terms and conditions pertaining to their participation in the respective CoP
- Memorandum of Cooperation (MoC), as an alternative means of cooperation scheme, in case a stakeholder does not want to sign a declaration.
- Informed Consent Form, with detailed description on how the CoP Leader handles personal data





How to create a CoP? 3. Mobilize members through specifically designed co-creation activities

Designathons

In a Designathon different stakeholders lock themselves in a room for e.g. 1 day and work on a broadly defined challenge for social good (training in the field of bioeconomy)

Co-Design Workshops

The aim is to define the key drivers for national bioeconomy and provide the input and validation to bioeconomy training and mentoring guidelines.

The project provides several benefits to its CoP's members, such as:


• Networking opportunities and possibilities for new collaborations arising from the participation in CoP

• Wider understanding of biosystems and key enablers in bioeconomy as balanced local potentials and innovation within the framework of local development and investment as well as national sustainability-driven policy


• Gain adequate information and guidelines that respond to the need of biosystems in each region and contribute to the transition to bioeconomy
